3. The proposed property is associated with the lives of persons significant in our past.
4. The proposed property embodies distinctive characteristics of a type or period, of method or construction, or possessed high artistic values, or represents a significant and distinguishable entity whose components may lack individual distinction.
5. The proposed property has yielded or may be likely to yield, information important in prehistory or history.
6. The proposed property represents types or styles of construction that were once common and now are among the last examples surviving in the County, the region, or the state.
