**BENTON COUNTY PROPERTY LINE ADJUSTMENT STANDARDS**

**ORS 209.250**

1. Survey shall be prepared by an Oregon licensed land surveyor.

**ORS 209.250 & ORS 92.060(7)**

2. Conforms to Benton County survey map standards (attach checklist).
3. Complies with ORS 92.010-92.190 and ORS 209.250.
4. Conforms to the Benton County Development Code.

Survey needs to show in addition to survey map standards for a survey:

- a. Acreages for each resulting properties.
- b. Show the entire boundary of the property being adjusted. May show entire area as an inset on survey map.
- c. Label area being transferred as area to be transferred. Show old property lines dashed.
- d. Label resultant properties (ex-property 1, property 2) as shown on the notice of decision. Label original lots, parcels, and deed lines that have been adjusted. May show tax lot numbers.
- e. Show Development file number.

**ORS 92.010(8)**

5. "Partition land" means to divide land to create not more than three parcels of land within a calendar year, but does not include:

**ORS 92.010 (9e)**

A sale or grant by a public agency or public body of excess property resulting from the acquisition of land by the state, a political subdivision or special district for highways, county roads, city streets or other right of way purposes when the sale or grant is part of a property line adjustment incorporating the excess right of way into adjacent property. The property line adjustment shall be approved or disapproved by the applicable local government. If the property line adjustment is approved, it shall be recorded in the deed records of the county where the property is located.

**ORS 92.010 (9b)**

6. Adjusting a property line as property line adjustment is defined in this section is not "partitioning land".

**ORS 92.010 (11)**

7. "Property Line" means the division line between two units of land.

**ORS 92.010 (12)**

8. "Property Line Adjustment" means the relocation or elimination of all or a portion of the common property line between abutting properties that does not create an additional lot or parcel.

**ORS 92.010 (13)**

9. "Replat" means the act of platting the lots, parcels and easements in a recorded subdivision or partition plat to achieve a reconfiguration of the existing subdivision or partition plat or to increase or decrease the number of lots in the subdivision.

**ORS 92.060 (7)**

10. Except as provided in subsections (8) and (9) of this section, a property line adjustment must be surveyed and monumented in accordance with subsection (3) of this section and a survey, complying with ORS 209.250, must be filed with the county surveyor.

**ORS 92.060 (8)**

11. Unless the governing body of a city or county has otherwise provided by ordinance, a survey or monument is not required for a property line adjustment when abutting properties are each greater than 10 acres. As per the Benton County Development Code a survey of the adjusted property line shall be completed for all lands zoned Urban Residential (UR) and Rural Residential (RR) and for resulting properties of ten acres or less in other zones. [Ord7, Ord 90-0069, Ord 92-0092, Ord 96-0118} Nothing in this sub-section shall exempt a local government from minimum area requirements established in acknowledged comprehensive plans and land use regulations.

**ORS 92.060 (9)**

12. The requirements of subsection (7) of this section do not apply to property transferred through a property line adjustment as provided in ORS 92.010 (9e).

**ORS 92.190 (3)**

13. The governing body of a city or county may use procedures other than replatting procedures in ORS 92.180 and 92.185 to adjust property lines as described in ORS 92.010(12), as long as those procedures include the recording, with the county clerk, of conveyances conforming to the approved property line adjustment as surveyed in accordance with ORS 92.060(7).

**ORS 92.190 (4)**

14. A property line adjustment deed shall contain the names of the parties, the description of the adjusted line, references to original recorded documents and signatures of all parties with proper acknowledgment.

**ORS 92.060 (3)**

15. Monuments of either galvanized iron pipe not less than one-half inch inside diameter or iron or steel rods not less than five eighths inch in least dimension and not less than 24 inches long. The county surveyor may authorize the setting of another type of monument or waive the setting of the monument in circumstances where setting the required monuments is impracticable.
16. Signature blanks with date for:
  - a. Benton County Planning Official or
  - b. City of Philomath Planning Official or
  - c. Planning Division Manager and City Engineer  
(City of Corvallis)
  - d. Community Development Director, City of Albany
  - e. Planning official for the appropriate city.
17. Send paper copy of final survey to City of Corvallis or polyester film to the City of Albany or paper copy to the appropriate city if needed.
