

2018 FORCED RELEASES

BENTON COUNTY JAIL

Forced releases occur regularly at the Benton County Jail. There are policies in place to determine which inmates will be kicked out due to lack of adequate bed space. Our Matrix Score policy determines a score by which deputies can determine who is the next inmate in line to be Force Released. The score is comprised of many different factors including current charge(s), employment, criminal history, whether or not they are currently supervised by Parole & Probation along with other factors. If an inmate is Force Released before they have completed serving their sentence, they are considered Sentence Served. They do not return to finish out their time. Pretrial inmates can also be Force Released depending on their Matrix Score. Below is a listing of the Forced Released for this year.
