

2018 Matrix Release and Cite to Appear

Due to the limited bed space in Benton County Jail, a Matrix Scoring system was developed. This system determines who stays and who go's when an individual is brought into the jail. If their matrix score is between 1-6 then they will be booked and released on their own recognizance with a future court date. If their matrix score is 7 or above then they must either post bail or remain in custody to be seen by the judge. If there are not enough beds available in order to keep the individual in custody then the Forced Release protocol kicks in and an inmate will be force released in order to keep those that have to stay. The list below represents those individuals who have been booked and released due to lack of space. If the arresting agency cites the individual then they are not held in jail.

Grey highlighted are those individuals who have been booked & released 3 or more times this year
